



## I CSOS LEGAL AND FINANCIAL ENVIRONMENT

The President Stands Ready to Address Issues Important for Development of the Non-Governmental Sector

On August 13, the representatives met with President of Latvia Egils Levits. During the meeting, the civil society representatives emphasised that non-governmental organisations play an important role as partners which cooperate with the government and local authorities in order to address issues of public concern. It is therefore essential that government is able to ensure a participationtransparent and oriented distribution of aid funding to the non-governmental sector.



During the meeting they also discussed the practices of European countries in engaging the NGO sector in dialogue with the government, as well as the adverse effects on NGO activities that have emerged in the last two years since the tax reform was introduced.

#### The First Meeting of the New SIF Board

On August 16, the new SIF Board had a meeting for the first time since the SIF Law's passage. The meeting addressed issues regarding the election of the chairman of the SIF Board, competition for the post of Director of the Secretariat and budget request for 2020.

On July 23, amendments to the SIF Law came into force aimed at improving the operation and supervision of the Fund. The main task is to change the composition of the Board which will make the operation of the Fund more efficient and transparent.
